 - -8-10 feet wide dirt/gravel trail
- g) Update on the Piedmont Park and Splash pad.

Chairman Dr. Paul Francel addressed the board

- -legal is getting wrapped up
 - -liens are dismissed
 - -individual suits are still ongoing but not the property
- -splash pad works
- -talking with City about doing an adult fitness pad, shuffle board and horse shoes
- -when City takes ownership we will get another \$40,000
- -when we have a date we will have to have a special meeting

Rebecca Anderson addressed the board

- -all public records have been posted to the Facebook page if anyone wants to look
- -we now have grills at the Park so we need to update our policy
- -we will open sometime this Spring
- -we will make a huge announcement once we have a final date
- h) Discussion, consideration and possible action on playground equipment by the gazebo.

- -use to have a playground next to the Police Department
 - -during PSA games it would be played on by kids
 - -want to put in new equipment
