Wind speed must be UNDER 10 MPH. Minimum distance from any structure is 150'. Clear area of combustible material should be no less than 15' around each pile. Maximum size of any one pile is 10' wide x 10' long x 10' tall for yard brush burning. Piles in excess of 10' wide x 10' long x 10' tall require a minimum distance from any structure of 500'. Must comply with all local and state regulations that are attached to this permit. MUST HAVE EARTH MOVING EQUIPMENT OR A WATER SOURCE ON SITE WHILE BURNING. THE PERSON MONITORING THE BURN MUST HAVE A COPY OF THIS PERMIT ON HIM/HER WHILE DOING SO. BURNING IS ONLY ALLOWED BETWEEN 3 HOURS AFTER SUNRISE AND 3 HOURS PRIOR TO SUNSET. ALL FIRES MUST BE COMPLETELY EXTINGUISHED BY DARK. MUST READ AND FOLLOW ALL PROVISIONS ON THE BURN PERMIT INFORMATION SHEET. CALL 373-5210 ON DESIRED DAY OF BURNING TO OBTAIN PERMISSION. VEGETATIVE MATERIAL ONLY, NO TRASH OR CONSTRUCTION DEBRIS. APPLICANT ASSUMES ALL RESPONSIBILITY FOR DAMAGE TO ANY AND ALL PROPERTY. APPLICANT HAS READ THE ACCOMPANYING BURN INFORMATION SHEET AND UNDERSTANDS THE REQUIREMENTS.

PERMIT TO BURN

- WIND SPEED MUST BE UNDER 10 MPH.
- MUST CALL 373-5210 BEFORE BEGINNING BURN.
- MUST HAVE COPY OF BURN PERMIT ON SITE & BE IN ATTENDANCE OF BURN AT ALL TIMES.
- VEGETATIVE MATERIAL ONLY, NO REFUSE OR CONSTUCTION DEBRIS.
- MUST HAVE WATER SOURCE OR EARTH MOVING EQUIPMENT ON SITE.
- YARD BRUSH MATERIAL MUST BE GENERATED ON THE SAME LOCATION AS THE BURN.
- YARD BRUSH BURN PILES CANNOT EXCEED 10' X 10' X 10.
- YARD BRUSH BURNING CANNOT TAKE PLACE WITHIN 150' OF A STUCTURE.
- BURN PILES IN EXCESS OF 10' X 10' X 10 REQUIRE A MINIMUM DISTANCE FROM ANY STRUCTURE OF 500'.
- LAND CLEARING & LAND MANAGEMENT BURNS MUST TAKE PLACE AT LEAST 500' UPWIND OF ANY STRUCTURE.
- NO BURNING IS ALLOWED UNTIL 3 HOURS AFTER SUNRISE. YOU MAY NOT IGNITE OR ADD ADDITIONAL FUEL TO A FIRE 3 HOURS PRIOR TO SUNSET.
- ALL FIRES MUST BE COMPLETELY EXTINGUISHED BY DARK.
- MUST READ & COMPLY WITH ALL ATTACHED REGULAIONS & GUIDELINES.
